2. Discussion: Beach Erosion – Action Update

There was a lengthy discussion between the Commission and residents on the beach erosion project. Mayor Hocevar reported that he received the contract proposals from the sand contractor, a contract from the coastal engineer that will oversee the initial work for the sand replacement and for the proposal for support for the continued work on the rock revetment wall. He also received the agreement between the Town and the Beach Club indemnifying them for the use of the Beach Club.

Mayor Hocevar addressed the two proposals that were given to him from Bernie Eastman's company. The first proposal for \$470,000 would use the free sand and the other proposal is for 7,000 cubic yards of sand from the Stuart Mines would cost \$643,330. With the first proposal, there were concerns with the free sand, which color wise satisfies DEP standards, it is a pile of sand and it is unknown what kind of debris it may have and it may be more work trying to clean it out. The other proposal was for sand that matches the grain structure and color to our beach. He also has a proposal from ATM to support the initial activity and if they use the free sand their cost would go up due to the additional effort to monitor the sand as it is being used. The cost would be \$40,000, not to exceed \$40,000. If the sand from Stuart Mines is used, it would be \$30,000.

Motion: Commissioner Rosner made a motion to accept the proposal with the additions that were mentioned by Vice Mayor Ciarfella and the insurances. Also, with the engineer's proposal.

Second: Vice Mayor Ciarfella seconded the motion.

Motion passed 5-0
