

RESOLUTION NO. 2022-02

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA, APPOINTING A TOWN CLERK; APPOINTING MEMBERS OF THE BUILDING AND ZONING COMMITTEE; APPOINTING MEMBERS OF THE SOCIAL COMMITTEE; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Article III, Sections 10 of the Town Charter and Section 5-10 of the Code of Ordinances of the Town provide that the Town Commission shall meet annually as soon as practicable following a general election for an organizational meeting; and

WHEREAS, the Town's general election was held on March 8, 2022. Groups 2 and 4 were scheduled for election. Group 2, Vice-Mayor Milton J. Block was not opposed for election: Group 4 had three candidates for the seat: Commissioner Cynthia Keim, Steven Pollard and Marie Rosner. No candidate received a majority of votes cast so a run-off election was held on March 22, 2022 between Commissioner Cynthia Keim and Marie Rosner. Marie Rosner was subsequently elected by receiving the majority of votes cast; and

WHEREAS, on March 28, 2022, the Town Commission held its annual organizational meeting; and

WHEREAS, in accordance with Article III, Section 11 of the Town Charter, the Town Commission may appoint a Town Clerk at its Organizational Meeting; and

WHEREAS, in accordance with Section 3 of the Zoning Code of the Town, the Town Commission is required to appoint members of the Building and Zoning Committee; and

WHEREAS, in accordance with Section 2-319 of the Town Code, The Town Commission is required to appoint members to the Social Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA, THAT:

SECTION 1. The above recitals are true and correct and incorporated herein by reference.

SECTION 2. The oath of office was duly administered to and taken by Commissioner Marie Rosner.

SECTION 3. The following individual is duly appointed as follows:

Ivelissee Chico-Randazzo Town Clerk

The above-referenced appointment is for a term of one (1) year or until her successor(s) is appointed and qualified but all subject to the pleasure of the Town Commission.

SECTION 4. The following individuals are duly appointed as members of the Building and Zoning Committee: Earl Fisher, Russell Bourne, Bill Gilbaine, Butch Harper and Karl Weintz.

The above-referenced appointments are for a term of one (1) year or until their successor(s) are appointed and qualified but all subject to the pleasure of the Town Commission.

SECTION 5. The following individuals are duly appointed as members to the Social Committee: Linda Davis, Jan Gardiner, Elizabeth Hailman, Heather Rotondi and Teryn Weintz.

The above-referenced appointments are for a term of one (1) year or until their successor(s) are appointed and qualified but all subject to the pleasure of the Town Commission.

SECTION 6. That all Resolutions or parts or Resolutions in conflict herewith be and the same are hereby repealed.

SECTION 7. If any provision of this Resolution or the application thereof is held invalid, such invalidity shall not affect the other provisions or application of this Resolution, which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Resolution are hereby repealed.

SECTION 8. This Resolution shall take effect immediately upon passage.
